# **General requirements for manuscripts**

1. The manuscript should be sent as a Word file (DOC, DOCX) and scanned with a PDF (with a signature of scientific adviser) to the e-mail: **raesk2020@gmail.com**. The name of the file is the name of the author (eg., Ivanov.doc).

2. Illustrations, tables, graphs and diagrams are not included in the text and should be attached as separate files. Do not use intervals, tab, forced hyphenation, macros and commands that run in automatic mode. You can create tables, graphs, and charts in Word and Excel.

3. The total volume of the manuscript (including the title, abstract and key words in English, references, information about the authors) should **not exceed 10 thousand printed signs** (including spaces).

4. The author and his scientific adviser are responsible for the originality of the materials proposed for publication. The organizing committee reserves the right to reject the materials in case of non-compliance with the requirements.

# **Requirements for the manuscript formalization**

The manuscript sent to the editors should be arranged as follows:

1. Title of the publication, brief information about the author(s). Footnote about the source of funding for the study is given after the title, if it is necessary.

#### **Requirements for references**

1. Internal links in the text must be given in square bracket: [Ivanov, Petrov, 2001, pp. 48–56]. If there are more than three authors, the name of the work is reduced to two or three words in square brackets: [The multilayered settlement of Adorma ..., 2007]. At coincidence of authors' surnames and year of publication the last of these is supplemented by the letter designation (a, b, c...) in the reference and in the list of references. Only provide references for the literature cited in the article.

2. The references should be arranged alphabetically without numbering. References should be made as introduced example shown below. All authors should be obligatory given. Publishers must be given for monographs. If the article has a DOI (Digital Object Identifier), it is strongly recommended to write one.

#### **Requirements to figures and tables**

1. Figures should be black and white (A4 format) and should be saved in TIF, JPEG format. All illustrations must have resolution 300 dpi. Links to figures in the text should be enclosed in parentheses – (Fig. 1.). If you need to specify the individual images in the picture, it should be done in the following way – (Fig 2, 5, 7–9); if links is made to a few drawings – (Fig. 3, 4-9; 4, 3, 5-8).

2. Tables and diagrams are presented in electronic form in Word and Excel. Links to the table are placed in parentheses in the article - (tab. 1; tab. 3–4).
