Graduate Program in Contemporary European and Greek History ΣΕΕΙ 249: The Interwar Balkans | Associate Professor Katerina Dalakoura

Right after the end of the First World War, an intense political activity emerged that led to the formation of international organizations, aiming to lead nations to a better understanding of and closer cooperation with each other, thus creating a climate of optimism about the prevalence of peace on a global scale. In the Balkans, this movement and climate is reflected, at first, in the bilateral Balkan treaties of cooperation and friendship and, later (in the 1930s) in broader Balkan collaborations, the revival of the idea of a Balkan federation, and the Balkan Treaty (1934). The seminar aims to explore these projects of Balkan understanding and cooperation, which were not only political/governmental initiatives, but also initiatives of social groups and agents as well as various collectivities. In the weekly meetings students will study and critically approach texts from relevant literature, which present this dense and complex movement, and undertake the task to explore and present, in a written essay and oral presentation, specific socio-political initiatives and forms of cooperation.

Abstract

The seminar focuses on the reception of the Ottoman past in Greek historiography and in cultural fields such as literature and cinema. Students are invited to study, comment on and discuss scholarly books and articles, literary works and a film and to identify stable features and changing attitudes in terms of both the fields of academic and public history and a chronological point of view. Alongside the Greek case, the Turkish case is examined in order to draw conclusions about the attitudes of two nation states and societies, one of which sees the Ottoman Empire primarily as a foreign yoke and the other as its national heritage.
